**Sub:- Eligibility of Liveries/Uniforms to erstwhile Gr. D employees now designated as MTS – regarding.**

Sir,

References have been received from the field offices/Hqrs seeking clarification on the issue of Eligibility of Liveries/Uniforms to the erstwhile Gr. D employees now designated as MTS. Instances have also come to the notice that some of the offices have declined to grant the erstwhile facility of Liveries/Uniforms as well as grant of Washing Allowance on the Liveries/Uniforms to the newly classified Group-C employees.

2. In this regard it is observed that on implementation of the 6<sup>th</sup> CPC, all the erstwhile Group-D posts have been classified as Group-C employees and re-designated as Multi Tasking Staff. The nomenclature of the work of these employees are altogether same and Govt. of India has so far not stopped the existing facility. It may be relevant to mention here that Ministry of Personnel, Public Grievance and Pensions (DoP&T) vide its OM No. F.No. 14/1/2010-JCA 2 has revised the stitching charges also.

3. In view of this the matter has been examined in consultation with the Finance Wing of the Head office and it has been decided to clarify that :


***"All MTS (erstwhile Group 'D' posts of Peon, Daftry, Jamadar, Junior Gestetner operator, Farash, Chowkidar, Safaiwala, Mali etc.) who were being issued Uniform/liveries and were expected to wear their respective uniforms while on duty before implementation of 6<sup>th</sup> CPC and selected Group "C" post of Staff Car Driver who were eligible for uniforms and***

**washing allowance prior to 6<sup>th</sup> CPC will continue to get Liveries / Uniforms and its usual Washing Allowance..."**

4. The cases regarding admittance of Liveries/Uniforms to erstwhile Gr. D employees now designated as MTS and Staff Car Drivers may be regulated accordingly.
