ORDER

On recommendations of the Screening Committee, held on 09.08.2011, the competent authority has approved 1st financial up-gradation under Assured Career Progression Scheme, 1999 in the PB-2 of Rs 9300-34800 with Grade Pay of Rs 4600/- (Rs 5500-175-9000 / 6500-200-10,500-Pre Revised Pay Scale) to the following officials / stenographers with effect from the date mentioned against their names :

2. The benefits of up-gradation of Pay Scale / Grade Pay is subject to the following conditions :

- (i) This is not a promotion but a financial up-gradation only under the ACP Scheme.
- (ii) The officials will continue to hold their substantive post.
- (iii) The officials will not claim seniority in the next grade by virtue of this up-gradation.
- (iv) Their name will continue to be in the seniority list of substantive post held by them and they will be considered for promotion as and when their turn as per the seniority list comes.
- (v) The 1st MACP benefits given to Smt. B.R. Chitra & Sh. Raj Kumar at Sl. No. 2 & 3 vide this office order no. HRM-VI/10(4)2001/MACP/25923 dated 05.08.2010 is, accordingly, withdrawn.

3. The fixation of pay of above officials will be regulated as per the para 9 of the Annexure-I of the ACP Scheme dated 11.08.1999. The financial up-gradation is, however, subject to the other terms & conditions prescribed in the ACP Scheme vide Department of Personnel & Training OM No. 35034/1/97-Estt (D) dated 11.08.1999, circulated by this office vide letter no. P.IV/3(2)99/5707 dated 22.10.1999.
