5. You are requested to kindly take personal interest and ensure maximum participation from amongst the un-exempted establishments falling in your jurisdiction.



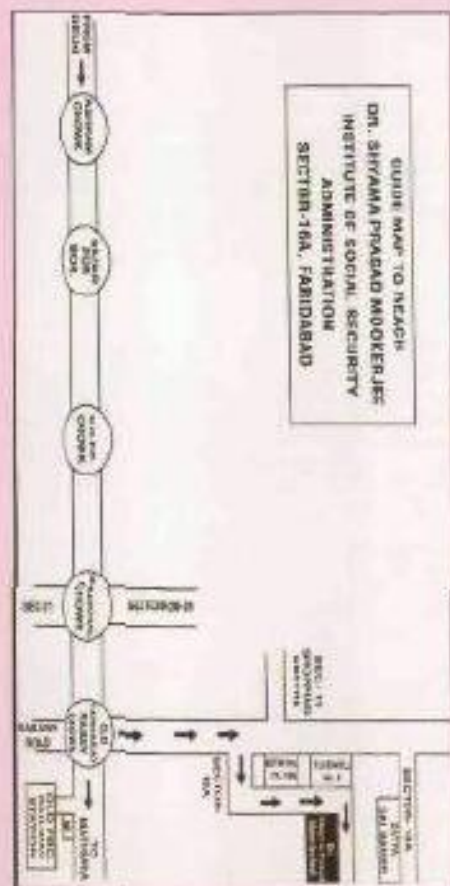

ABOUT ZONAL TRAINING INSTITUTE (NORTH ZONE)

The Zonal Training Institute, North Zone, Faridabad now known as Dr. Syama Prasad Mookerjee Institute of Social Security Administration (SPMISSA), was set up in the year 1993 under the administrative control of National Academy for Training & Research in Social Security (NATRSS), New Delhi to meet the challenges of Human Resource Development in Employees' Provident Fund Organisation (EPFO), Ministry of Labour & Employment, Govt. of India. Employees' Provident Fund Scheme, 1952, Employees' Pension Scheme, 1995 (replacing Employees' Family Pension Scheme, 1971) and Employees' Deposit-Linked Insurance Scheme, 1976.

RATIONALE

The concept of Social Security is acquiring wider dimensions with the growth of Industry vis-a-vis increasing needs for human existence. While the Employees' Provident Fund Scheme framed in 1952 under the EPF & MP Act had been a major legislation enacted to ensure better Social Security for the organized working class, the Employees' Pension Scheme, 1995 is another milestone in accomplishing the objectives set forth in the Constitution of India. There is yet another scheme called Employees' Deposit Linked Insurance Scheme that was framed in 1976 to provide some consolidated monetary consolation to family in case of death of an employee. By administering these schemes, the Employees' Provident Fund Organisation is striving hard to excel in delivery of social security benefits.

Nevertheless, the administration of Social Security legislations like Provident Fund and Pension would be difficult if the personnel at the helm of affairs of covered establishments are not aware of requirements of beneficial legislations like EPF & MP Act.

It is observed that many executives/employees dealing with Provident Funds in their establishments are not Social Security professionals. Now it is necessary for them to excel in this particular field, keeping in view the volume and variety of work they are required to handle in their respective organisation. In other words, managing of social security is a negligible part of the overall functions of Personnel Executive of an establishment. But having far reaching effects on the existence of an establishment, there is an urgent need to familiarise the Employers / Members of the Fund with Social Security legislations specially the Employees' Provident Funds and Pension Scheme.

Realizing the importance of increasing trend of professionalism in implementation of the Act, Dr. Syama Prasad Mookerjee Institute of Social Security Administration (SPMISSA), Zonal Training Institute (NZ) has decided to organize a special Two-Day Workshop for the Employers / EPF Members of covered establishments at its own complex at Faridabad.

OBJECTIVES

- To familiarize the Employers / EPF Members about the objectives and requirements of the Employees' Provident Fund Organisation.
