Subject: Grant of Pay Structure of upgraded Grade Pay of Rs.4600 in PB-2 to the post that exists in the pre-revised scale of Rs.6500-10500 as on 01.01.2006 which were granted the Normal replacement Pay structure of Grade Pay of Rs.4200 in PB-2.

Madam/Sir,

Several representation/queries have been received from certain Regions seeking clarification regarding manner of pay fixation in respect of EO/AO on grant of upgraded Grade Pay of Rs.4600 in PB-2 to the post of EO/AO that existed in the pre-revised scale of Rs.6500-10500 as on 01.01.2006 which were granted the Normal replacement Pay structure of Grade Pay of Rs.4200 in PB-2.

2. In this regard, it is reiterated that the manner of pay fixation has already been clarified vide this office circular No.HRD/1(2)2008/Implementation of 6th CPC/16306 dated 17.03.2010 and circular No.HRD/2(3)82/EO-AO/Pt-III/43140 dated 19.10.2010 (copy attached).

3. In view of the above, the fixation of pay of the EO/AOs on or after 01.01.2006 may be reviewed/revised accordingly and recover the excess amount paid, if any.

Sir,

Please refer to DOPT circular no. 1/1/2008-IC dated 13/11/2009 was circulated vide this office letter no. HRD/1(1)2009/circular/8885 dated 23/11/2009.

In this regard, queries have been received from certain regions seeking clarification whether Grade Pay of Rs. 4600/- is applicable for cadre of EO/AO having pre-revised pay scale of 6500-10500.

The matter has been examined in the light of aforesaid circular in consultation with the finance wing and it is clarified that the Grade pay Rs. 4600/- is to be granted to the cadre of EO/AO in accordance with the aforesaid circular of DOPT dated 13/11/09.

Further, it is clarified that as per this office letter no. HRD/1(9)2003/Pay Scales/Pt-II/60951-61101 dated 15 Nov 2007, the cadre of EO/AO was placed in pre-revised pay scale of Rs 6500-10500 notionally w.e.f 1/4/2004 with actual financial effect from 1/09/2007, therefore the financial benefits in accordance with the DOPT circular in the cadre of EO/AO shall be effected w.e.f. 1/09/2007 onwards.


Please refer to this office letter no. HRD/1(2) 2008/Implementation of 6th CPC/16306 dated 17.03.2010 on the subject mentioned above wherein Grade Pay of ₹4600/- in place of ₹ 4200/- was allowed to the cadre of EO/AO.

In this circular, it was further clarified that as per the H.O. letter NO. HRD/1(a)2003/Pay scales/Pt.II/60951-61101 dated 15/11/2007. The cadre of EO/AO was placed in pre-revised pay scale of ₹ 6500-10500 notionally w.e.f. 1/04/2004 with actual financial effect from 1/9/2007, therefore the financial benefits in accordance with the DoPT circular in the cadre of EO/AO shall be effected w.e.f. 1/09/2007 onwards.

In this regard, it is to state that it has come to the notice of the Head Office that while implementing the above mentioned order of granting Grade Pay of ₹4600/- to EO/AO, the benefit of pay fixation has also been extended by some regions, either by giving increment or by fixing the basic pay corresponding to pre-revised pay scale of ₹7450-11500/- by using fitment table. This is totally erroneous and against the spirit of the order.

It is once again clarified that the aforesaid letter permits the grant of only Grade Pay of ₹4600 in place of ₹ 4200 and no benefits of pay fixation i.e. grant of any increment or fixation of pay using fitment table corresponding to pre-revised scale of ₹7450-11500/- are to be given in this regard. If such benefits have been given, then the recovery of the excess amount should immediately be effected and an action taken report be sent to this office by 29th October 2010 positively.
