Madam/Sir,

It is informed that an agenda was placed in 232<sup>nd</sup> CBT meeting held on 31.10.2022 for the reconstitution of the Executive Committee and other non-statutory sub-committees of CBT and EC. In the meeting, the Board unanimously authorized the Chairman, CBT to reconstitute Executive Committee (EC) and sub-committees of the CBT & EC.


3. The terms of reference of the Exempted Establishments' Committee are as under:


