Shri R.K.Kukreja, Secretary, Central Sports Promotion Board/R.P.F.C. (HRM) and Smt. S.M.Adhikari, Member West Zone, could not attend the meeting as they were on leave. Shri J.P. Chauhan, Treasurer, Central Sports Promotion Board/R.P.F.C. Banking could not attend the meeting as he was deputed at NATRSS for official work.

At the outset, the President, Central Sports Promotion Board welcomed all the members of the Central Sports Promotion Board followed by introduction of participants. Then Agenda items were taken up for discussions as detailed below:

Item No. 1 Confirmation of the minutes of the last meeting held on 6.2.2009.

The minutes of the 20th meeting of the Central Sports Promotion Board held on 6.2.2009 as circulated vide Office letter No. Sports. 2(1) 28th Meeting/CSPB/2009 dated 18th February 2009 were confirmed.

Item No. 2 **Action taken report on the decisions of the last meeting held on 6.2.2009.**

The Central Sports Promotion Board noted the action taken on the decisions in the last meeting.

All the Members of the Central Sports Promotion Board requested the President, Central Sports Promotion Board to restore the Basketball Event, which was deleted during the year 2009-10. The President, Central Sports Promotion Board desired to know the reasons for deletion of Basketball from Sports Calendar of the EPFO. It was brought to the notice of the President, Central Sports Promotion Board that the game being the technical in nature was deleted. After lot of discussions, the Central Sports Promotion Board unanimously requested the President to restore the Basketball as deletion of the game is depriving the Sports Quota players and other participants from playing the game. On the demand from every corner, the President, Central Sports Promotion Board restored the Basketball and decided to conduct the event with Volleyball event. The decision of the President, Central Sports Promotion Board was welcomed.

Item No. 3 **Report of the Secretary, Central Sports Promotion Board on the Receipt and Payment Accounts for the year 2008-09 and activities conducted in the year 2009-2010.**

In the absence of Secretary, the Assistant Secretary read the Secretary Report. The Central Sports Promotion Board noted the contents and appreciated the work done in the field of Sports Activities.

Item No. 4 **Receipt and Payment Account for the year 2008-09.**

The Central Sports Promotion Board approved the Receipt and Payment Accounts of the Central Sports Promotion Board for the year 2008-09 with the following observations:

- The President Central Sports Promotion Board desired that Agenda of the meeting should be sent to all members at least 7 days in advance so that the Members could read the Agenda properly.
- The Central Sports Promotion Board unanimously decided to open the Savings Bank Account of the Central Sports Promotion Board in the State Bank of India so that amount spent on Commission can be saved.

Item No. 5 **SPORTS CALENDAR FOR THE YEAR 2010-2011.**

With the restoration of Basketball in the Sports Calendar of E.P.F. the President, Central Sports Promotion Board directed the Welfare Officer to reschedule the events.



Accordingly, the Sports Calendar for the year 2010-2011 is rescheduled and is appended herewith.

Some members of the Central Sports Promotion Board desired that Traveling Allowance for the participants should be met from the Sports Fund and not through the regular T.A. Head so that full expenditure on the Sports Head could be ascertained. The President, agreed to the proposal. The Vice President brought to the notice of the President that the same can be done only from the year 2011-12 as the CBT have already allocated the Funds for the year 2010-11. The President agreed to the submission made and decided that for the year 2010-2011, the T.A. will be debited under the regular T.A. head and from the Financial Year 2011-12 to the Sports Fund so as to reflect the true picture of the amount spent on Sports Activities.

Item No. 6 **PROPOSALS RECEIVED FROM REGIONAL OFFICES.**


The Central Sports Promotion Board unanimously approved the proposal and allotted the Athletic and Indoor Finals at Bhubaneswar to commemorate the Silver Jubilee year of the Sports in the E.P.F.O.

Item No. 7 **ALLOTMENT OF BUDGET FORMULA.**

The budget is allocated itemwise for each event taking into account the Delhi standard rates and the previous expenditure incurred on such items by the Regions. Since, Basketball game has been restored, budget for the Basketball game is also worked out on the similar lines.

Item No. 8 Any other item with the permission of the Chair.

- The members of the Board discussed the issue of not granting the Uniform every year. It was brought to the notice of the President, Central Sports Promotion Board that uniform @ Rs. 800/- is being granted to players of the EPFO after three years. The members expressed:
 - i) The Uniform cannot last for three years.
 - ii) If new players come in the team, colour of the uniform do not match with the old uniform.
 - iii) In March-past, the participants give a shabby look as they are in different colour.
 - iv) Wearing different colour uniform may not be appropriate in the sports events.
 - v) The Public Sector Undertakings are encouraging Sports by way of providing different facilities and EPFO should also encourage their sportsmen to perform better.



- vi) Wearing uniform of different colour attracts indiscipline also and may not bring oneness in the team.
- vii) It was also brought to the notice of the Central Sports Promotion Board that PSUs are providing uniform to their players @ Rs. 2,200/- per year.

After lot of discussions, the President, Central Sports Promotion Board after consideration of various aspects of this issue agreed to grant uniform @ Rs. 1,500/- per year to each of the participant by the Regional Sports Promotion Board, as per availability of budget.

- The All India EPF Cricket and Football coaches brought to the notice of the Central Sports Promotion Board that the EPFO National teams are not able to perform better because in each PSU team, they are having players on Scholarship which enable them to perform better. It was also brought to the notice of the Board that Central Sports Promotion Board has also approved the players to be allowed to play from the EPFO on scholarship basis and their contract would be for four months and the Scholarship amount would be Rs. 4,000/- per month. Both the Coaches as well as other members of the Board requested the President, Central Sports Promotion Board to allow 5 players to be allowed to play for EPFO in Cricket and Football. Initially their contract would be for four months and they will be paid Rs. 4,000/- besides T.A. & D.A. from the Sports Fund for participating All India Public Sector Tournaments. For calling applications, advertisement will be placed on EPFO Website and preference would be given to the wards of the employees of the EPFO who have the similar qualifications and skills.


The President, Central Sports Promotion Board on the request made by the members of the Central Sports Promotion Board approved the proposal.

The President, Central Sports Promotion Board also expressed that the players in the Tournament ^{would} shall rise to the occasion and improve their performance. The President further emphasized on the discipline to be observed during the Tournaments.

The President, Central Sports Promotion Board directed the Welfare Officer to revise the budget as per the decisions taken.

- The President, Central Sports Promotion Board desired that Chief Vigilance Officer to be nominated as Ex Officio member of the Central Sports Promotion Board from the next term.

The meeting ended with vote of thanks to the Chair.
