**OFFER OF APPOINTMENT**

**Subject: Appointment of Shri Pavittarpal Singh, Section Officer, Central Public Works Department, Nirman Bhawan, New Delhi – 110 011 as Assistant Director (Vigilance) on deputation basis in Employees' Provident Fund Organisation.**

On the basis of the recommendation of the Selection Committee constituted for selection to the post of Assistant Director (Vigilance) on deputation basis in EPFO, **Shri Pavittarpal Singh, Section Officer, Central Public Works Department, New Delhi** is hereby issued an offer of appointment to the post of Assistant Director (Vigilance) in Level-10 of the Pay matrix [Pay Band-3 Rs. 15600-39100 with Grade Pay Rs.5400/-(pre-revised)] in Employees' Provident Fund Organisation on deputation basis initially for a period of three years from the date of joining the post of Assistant Director (Vigilance).

2. The terms and conditions of appointment on deputation are as follows:-
  - i) The terms and conditions of deputation will be governed by O.M. No. 2/229/91-Estt./(Pay II) dated 05.01.1994, O.M. No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 and other instructions / Memorandum issued by Ministry of Personnel, Public Grievances and Pension, Department of Personnel & Training, Government of India from time to time.
  - ii) The posting of the official as Assistant Director (Vigilance) shall be at **Zonal Vigilance Directorate, Chandigarh**. However, the official may be transferred to any other EPFO office location on administrative grounds.
  - iii) The appointment order will be issued once the written consent of the official is received accepting the terms and conditions as mentioned in the offer of appointment as well as latest Vigilance Clearance Certificate.
  - iv) In case the selected official seeks repatriation before completion of two years on deputation, no transfer TA/DA will be paid on repatriation. Further, if the official seeks repatriation within one year or less, Transfer TA/DA already paid, if any is also liable to recovered.
  - v) The official will be entitled to TA/DA and joining time as per rules.
  - vi) On expiry of three years from the date of joining the post, the deputationist officer will be deemed to have been relieved on the date of expiry of the deputation period unless the Competent Authority has with requisite approvals, extend the period of deputation in writing, prior to the date of its expiry.
  - vii) In the event of the officer overstaying for any reason whatsoever, he is liable for disciplinary action and other adverse consequences which would include that the period of unauthorized overstay shall not count against service for the purpose of pension and that any Increment due during the period of unauthorized overstay shall be deferred with cumulative effect, till the date on which the officer rejoins his parent cadre.

3. If the above terms and conditions are acceptable to **Shri Pavittarpal Singh, Section Officer, Central Public Works Department**, he may send a written consent through proper channel alongwith latest Vigilance Clearance Certificate to this office within 10 working days of receipt of this offer of appointment.


