Please refer to UPSC Public Notice No. F.1/165(33)/2022-R.IV/SPC-I dated 15.07.2024 wherein you were declared successful as a candidate for the post of Assistant Provident Fund Commissioner (APFC) in EPFO. Vide EPFO Head Office Letter No. Exam.8(1)2024/APFC/DR-119 dated 05.08.2024, you were asked to complete the pre-appointment formalities for enabling EPFO to issue you offer of appointment.
