Please find enclosed herewith the result of the Limited Departmental Competitive Examination for promotion to the post of Lower Division Clerk /Junior Secretariat Assistant against the vacancies under Examination quota which was held on 22.11.2024 in accordance with notice No. A-34012/1/2022-Exam/75 dated 11.06.2024.

2. The result has been prepared based on the Employees Provident Fund Lower Division Clerk/ Junior Secretariat Assistant Limited Departmental Competitive Examination Scheme, 2023. As per the Scheme, the General Category candidates who have scored at least 40% marks in each Part of the Examination and Reserved category (SC/ST) candidates who have scored at least 35% mark in each Part of the Examination have been declared qualified. The number of candidates declared successful for each region/political state is only to the extent of vacancies notified for the region/political state. In case two or more candidates have the same marks, the candidate senior most in the feeder cadre has been considered as having higher rank than the other candidate(s).
