
OFFICE ORDER

Sub: Appointment to the post of Regional Provident Fund Commissioner (Grade-I) in level-12 of Pay Matrix on regular basis- Reg.

On recommendation of Departmental Promotion Committee held on 26.12.2023, the Chairman, CBT, EPF is pleased to approve the appointment of Shri Surjeet Kumar, RPFC-II to the post of Regional Provident Fund Commissioner (Grade-I) in Level 12 of pay matrix [pre-revised PB-3 (Rs. 15600-39100) with Grade Pay of Rs. 7600/-] on regular basis with effect from the date of assumption of charge at his present place of posting in-situ and until further orders.

2. On regular promotion, the officer will continue at the present place of posting in-situ till further orders. The regular promotion will be effective from the date of assumption of charge. The posting order of the officer will be issued separately.

The seniority of the officer will be regulated in the cadre of Regional P.F. Commissioner-I as per the provisions of EPF Staff (Fixation of Seniority) Regulations, 1989.
5. The joining report of the officer as Regional P.F. Commissioner-I shall be forwarded to HRM, Head Office by the respective controlling office through Email to rc1.hrm@epfindia.gov.in. Further, the same shall also be updated on HR-Soft Portal.
6. The promotion of the above mentioned officer is subject to the outcome of the OA No. 435/2021 (related MA) filed before Hon'ble CAT, Patna.
