On recommendations of the Departmental Promotion Committee held on 13.07.2023, the Hon'ble Chairman, CBT, EPF is pleased to approve the appointment of Shri Shishir Kant Jha, RPFC-I to the post of Additional Central P.F. (D) dated 28.04.2014). The seniority of the officer will be regulated in the cadre of Additional Central P.F. Commissioner as per the provisions of EPF Staff (Fixation of Seniority) Regulations, 1989.
