Sir/Madam,

Subsequent to the issuance of the re-allocation order for 708 SSAs on 12.12.2024, several emails have been received from candidates expressing their unwillingness to move to their newly allocated states. The emails are being sent to Email IDs of different sections/divisions of Head Office.

2. Considering the large number of SSAs involved, it is imperative to systematically compile the data of such candidates to address their concerns effectively. Therefore, SSAs who have been reallocated as per the aforementioned order are instructed to submit their representations if any for retention in the same zone through his/her Regional Office and Zonal Office. RO will send the representations of retention submitted by the SSAs to their Zonal Office by 24.12.2024. The Zonal Offices are requested to compile the representations received from all the ROs under them and forward the same to Head Office alongwith the attached **Annexure-A** on the dedicated **email ID, apfc.dr@epfindia.gov.in**, by **27.12.2024**. Any representation received after 27.12.2024 will not be entertained. Furthermore, representations submitted through any mode other than the designated email ID will also not be entertained. Representation should be submitted duly signed by the SSA. Unsigned representation will not be entertained.

3. The concerned SSAs can submit the advance copy of their representations on the above indicated email id.

4. SSAs are directed to include the following details in their representation:
- i.Rank
 - ii.Application Number
 - iii.Name of the SSA
 - iv.Current Allocated State
 - v.Newly Allocated State
 - vi.Reason for unwillingness

5. It is also reiterated that only representations related to the retention in the same zone may be sent. Representations regarding transfer, inter-regional transfer, mutual transfer, requests for change of preferences submitted at the time of filling of application form or request for reallocation to any other zone will not be addressed.
