
In the cases where respondents are Ministry of Labour, Central Board of Trustees of EPFO, Central P.F. Commissioner or any other officer(s) of the Organization and the case(s) is/are defended by Regional P.F. Commissioner on behalf of all respondents, the Advocate will be entitled to only one set of fee.

The scales of fee to the Advocate will be regulated as prescribed by the Ministry of Law & Justice for Central Govt. Standing Counsels in High Court, CAT and Lower Courts circulated by Head Office vide letter No. LC-4(1)16/18332 dated 25.01.2017. The empanelment of Advocates is subject to various terms and conditions, duties and responsibilities circulated vide Head Office letter No. LC-3(14)2010/EPFAT/Vol.V/1264 dated 27.04.2017/03.05.2017 and circulars/orders/OMs mentioned therein.

The empanelment will be valid up to **31.03.2019**.
